## 2020-2021 IMSA Student Registration

The registration process has changed due to IMSA using a new platform. Please refer to the email sent to both parents and students on May 7, 2020 and May 22, 2020 from mratsamy@imsa.edu. The email includes specific instructions for each individual student, please read carefully. Registration forms must be complete and submitted by Monday, June 15, 2020 to avoid the late fee of \$50.00. ## STUDENT FEES INFORMATION

(Email from Ann Donohue was sent on June 10, 2020 to all rising Junior and Senior Families)

Every academic year, IMSA families need to set up how they want to pay their child's student fee. As of today, rising Juniors and Seniors have been invoiced for the upcoming 2020-2021 academic year.

#### I. Student Fee Payments

- **Due date:** All initial payments, or full payments, must be made online through the MySchoolBucks link in your PowerSchool parent/guardian account, between June 10, 2020 and July 15, 2020.
- Parent PowerSchool login: Please contact <u>Minerva Ratsamy</u> in Student Affairs if you have forgotten your parent PowerSchool login information.
- Amount Due: The entire yearly fee amount is due in full, on or before July 15, 2020.

IMSA also offers an installment payment plan option, if you choose the payment plan option the one time non-refundable \$50.00 Payment Plan fee will need to be paid on your Student's account once the first partial payment is received.

- Accepted forms of online payment Electronic check, electronic savings withdrawal, or credit card.
- Online payment access: Information will be available starting June 10th.

All initial payments, or full payments, must be made online through the MySchoolBucks link in the PowerSchool parent/guardian account, between June 10, 2020 and July 15, 2020. If you do not pay the \$50.00 Payment Plan Fee, the entire yearly fee amount is due on or before July 15, 2020.

A link with each class's Student Fee information, and the Student Fee Reduction application is included below. The invoiced student fees, in MySchoolBucks, reflect a 50% reduction for the 2020-2021 academic year.

### II. Student Fee Reduction Applications

Families that have already submitted an application for a reduction in their 2020-2021 Student Fee, have been invoiced for the tier-level that they qualified for. (The invoiced Tier-levels in MySchoolBucks also reflect a 50% reduction for the 2020-2021 academic year.) If you have not submitted an Student Fee Reduction application yet, please do so soon.

To apply for a reduction in your student fee for the 2020-2021 school year, please return a fully completed application and all supporting documentation to the Office of Business and Financial Services on or before July 1, 2020. Approved fee reductions on applications received on or before July 1 will be applied to the entire school year.
